A New Year

This year, the Maine Children's Home for Little Wanderers begins its 110th year of service to children and families. Each year, it seems, we are asked to do more because the need is so great. The Home has always responded.

The Maine Children's Home accomplished some wonderful things in 2008. We provided Christmas for 1,568 children and proved to them that Santa Clause still exists. We sent 120 children to a weeklong summer camp experience and had 27 young mothers enrolled in our Teen Parent School Program. The Children's Place provided care and education for 77 children from infancy to school age. The Turner Family Counseling Center provided counseling for 348 children and adults and our Adoption/Family Care Unit impacted 312 lives.

New Board Members



While doing all of that, a new program called CAST (Coping and Support Training) was started, thanks to a seed grant from the Frances Hollis Brain Foundation. CAST is a high school based suicide prevention program targeting youth 14 to 19 years old. CAST delivers life-skills training and social support in a small group format (6-8 students per group).

A Message from the Executive Director

Everywhere you look or even listen these days, headline news and coffee shop talk tends to head in one direction. Market drops by record numbers, major lay-offs expected, government cuts millions from the budget, programs cut services and businesses closing. For most of us, this is the worst of times in our experience. For those of you who are my vintage, you may be even thinking that the retirement of your dreams is just that, a dream, not your reality. But whatever your age, or life calling, clearly we have all been dramatically affected by everything that has transpired economically this past year and will for perhaps the next few years.

One of the things that I have realized during this time is that the old adage, “When the times are tough the tough get going,” is really very true. But the other thing that I have come to understand is that it is during difficult times like this, that make us clarify what is really important in life. It isn’t the money, the big house and stocks and bonds that give quality to your life or are really important. It’s the people, our children, family and friends, neighbors and what they give to you and you give in return that count.

Although most of you reading this newsletter are well connected to the Maine Children’s Home, there are many who have less knowledge about us. What is the Maine Children’s Home? It is an organization that is now 110 years old, whose mission is to build and strengthen families and their children, instilling hope for the future and a better quality of life. Since our inception, we have brought thousands of families together through our adoption programs, and over the years new programs have been developed and expanded our mission. For the past 35 years, our Teen Parent School Program has done just that for over 1000 teen moms and their children, who have become successful parents and adults. Two members of this year’s Board are graduates of this program, and we are proud to employ a graduate for the past 4 years.

The Children’s Place is one of our newer programs since moving to the Bibbi Alford Campus almost 7 years ago. That program offers a wide array of early care and educational opportunities. Quality programs cost dearly and, in order to keep up to the standards for future accreditation and keep our fees affordable for parents, this program and others need financial support from various sources, parents, business and government. What is learned in the first 5 years of life cannot be replaced later without stress, complications and incredible cost.

All of our programs are enhanced with the ability to offer outpatient mental health counseling when issues become too complex to be met under normal programming. The Turner Family Counseling Center will no doubt see increased requests for counseling with the stress families continue to face with our current economic crisis.

Miracles do happen during these difficult times as evidenced by this year’s Christmas Program. Under the direction of Cristen, Steve, Janelle, Devon, our Friend’s members and our unbelievable friends at 107.9 The MIX, even with the financial odds against us, we were able to make Christmas wishes come true for 1,568 needy children. Some individuals chose not to exchange gifts, and gave to “our” children instead. Over 300 volunteers spent countless hours pulling what was needed together. It took the National Guard to bring all the boxes to Augusta, but it was the heart and giving spirit of the greater community that made it all happen. This is the kind of spirit that will continue to inspire and ensure that the work of the Home is there for those who need the programs offered.

This past year, the lives of almost 3,000 children and families have been changed forever thanks to the work of the staff at the Maine Children’s Home, the Board, the Friends and all our contributors. The need is not going to go away, as a matter of fact it will undoubtedly continue to grow during these unsettled times. We must all look inside ourselves and see how we can contribute to strengthen families and their children, instilling hope for the future and a better quality of life. For the most part, our children, grandchildren and others close to us are fortunate to receive the nurturing and mentoring they need to be successful in the world. Unfortunately, that is not true for many other children and youth. Our future as a community, and even as a nation, can continue to be strong if we all do what we can to ensure that each and every child has the nurturance given to them by caring people today and provided with many opportunities to help them make a bright future for themselves tomorrow. Today's economic challenges are causing businesses and non-profits to operate more cost effectively. I think those who have come before us read the "tea leaves" early on and prepared us for these uncertain times. Under the leadership of Sharon Abrams, previous Board Presidents and staff, steps have been taken to stretch our funds and collaborate with other community agencies and businesses, and our mission will continue.

Our Board transition has been seamless. The "tea leaves" indicate a favorable future with volunteers and business connections for our numerous programs in 2009.

The program consists of 12 55-minute group sessions administered over 6 weeks by trained master's level instructors. CAST serves as a follow-up program for youth who have been identified through screening as being at significant risk for suicide. The program was a success and plans call for continuing and expanding the program this year, if additional funding can be found.

With the beginning of a new year comes the start of a new fundraising season. This month, we will kick-off our Annual Campaign. This year's theme is "**Love Begins at The Home**". When you consider the number of lives MCH has touched over the years, the statement could not be truer.

The Home is fortunate to have so many friends and businesses, many of them loyal supporters, who believe in and support the work we are doing. Our Annual Appeal is our first effort in 2009 to raise the funds necessary to support our programs. Please consider making a gift to The Home. We hope that we can always maintain your support and trust in what we are trying to achieve.

1,568 Children Still Believe In Santa

Here at the Christmas Program, it is always hard to convince businesses, organizations and individuals to get their Giving Trees and Toy Drives started early so that we are able to get enough inventory collected in time to meet our packing deadline. There are some pretty scary moments in our building when we realize that we are very low on things to pack, while the phone rings nonstop with calls from families who need our help. With donations slow to come, 2008 was an especially challenging year.

With a record 1,568 children depending on us, and inventory being packed as fast as we could get it, we often found ourselves wondering, for the first time ever, if we could realistically get this done.

Simply put, the donations came slowly. But the volunteers did not. In 2008, we not only had a record number of applicants, we also had a record number of first-time volunteers. Past volunteers also came out in droves, sometimes working along side us into the night to make sure that each box was carefully and thoughtfully packed. We now have a pool of over 200 active volunteers we can rely on to help children throughout the state of Maine to believe in Santa Claus.

And, although, donations were slow, they did come, and donors were very generous. The Christmas Program collected over \$145,000 in inventory from businesses, organizations, churches, schools and individuals who collected clothing and toys. We also collected \$9,521.00 in inventory after distribution, which will be used to start packing next season. We estimate that each child received an average of \$92.00 worth of clothing, toys, books and more through our program.

At the Christmas Program, we are firm believers in planning ahead; our minds are already well into Christmas 2009. With the current economy and promises that things will probably get worse before they get better, we can't help but be concerned about the struggle we may face next season. With bargains to be had on warm winter clothing, thinsulate gloves and mittens and toys, it's a great time to shop and help give us the peace of mind knowing that no child will go without. Additionally, if we can convince our Christmas helpers to start their Giving Trees and Toy Drives early next season, we will be well prepared to meet the needs of the families we serve.

New Adoption Triad Support Group Offered

The Maine Children's Home for Little Wanderers is an agency that has provided adoption services and worked directly with adoptive parents, birth parents and adoptees for over a hundred years. In response to the new Maine law, effective January 2009, granting adult adoptees, their attorneys and descendants access to their original birth certificate, The Maine Children's Home for Little Wanderers plans to establish a support group for adult adoptees, birth parents and adoptive parents, if there is sufficient interest. The support group would be held once a month on a Wednesday evening, with the starting date to be determined. We would expect a minimum of 6 to 8 attendees to make the group worthwhile. The meetings will be open to any members of the adoption triad including members who have no affiliation with The Maine Children's Home.

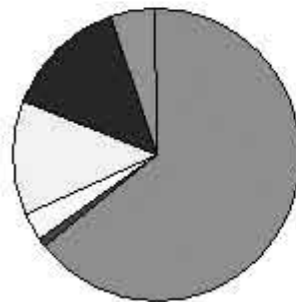

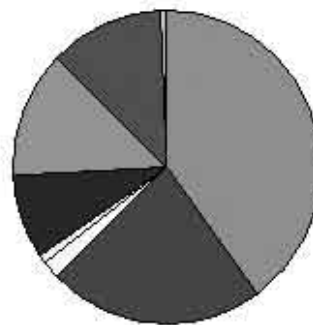
