From the Executive Director

Your support in 2025 brought warmth, comfort, and hope to families across Maine. Winter care packages were made for 1,529 children and teens in 15 counties, ensuring essentials reached families facing financial hardship. At our Family Counseling Center, children, teens, and adults participated in 4,178 mental health counseling sessions, receiving guidance and support to build resilience and stronger family relationships.

Through Journey Program, 33 young parents gained tools to thrive, while their children received childcare and essential supplies. And our Family Adoption Program supported seven children moving toward permanent, loving homes while helping more than 100 families explore adoption.

I am inspired daily by you and by the compassion and generosity of this community that makes our work possible.

Each number in this report represents real lives changed — children, parents, and families strengthened because of your generosity. I am grateful to be part of this mission and look forward to what we will accomplish together for Maine's children and families.

CHRISTMAS / WINTER ESSENTIALS PROGRAM

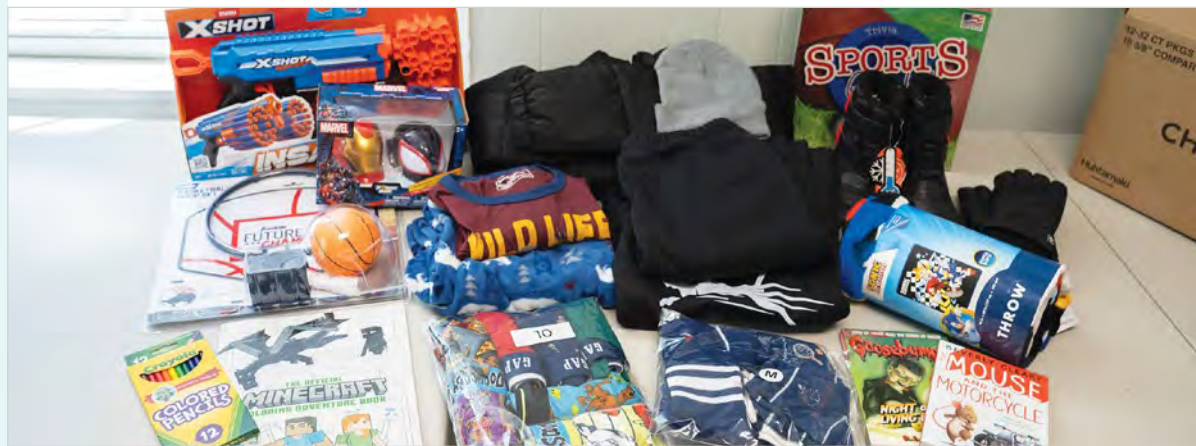
You Delivered Warmth and Joy

Because of your generosity, winter care packages were filled for a total of **1,529 children (ages infant through 12) and teens (ages 13–17)** across Maine, bringing warmth, safety, and hope to families facing financial hardship.

A total of **607 families** were reached — all households among the 42% of Mainers struggling to make ends meet. These families live at or just above the federal poverty level, meaning their income isn't enough to consistently cover essentials like housing, heat, food, and clothing.

Your support made these care packages possible, helping ensure that children and teens experience the comfort and safety they need during the harsh winter months and letting families know their community stands with them.

Every care package from Maine Children's Home is thoughtfully filled with brand-new essentials — warm clothing, pajamas, a hat, gloves, boots, a coat, books, toys, and personal care items — carefully selected to match a child's size, needs, and interests. Below is an example of the contents of a typical care package for a 10-year-old child.

FAMILY COUNSELING CENTER

You Supported Access to Healing

Thanks to your support, children, teens, adults, and families had access to warm and compassionate mental health support through our Family Counseling Center.

In 2025, clients of all ages participated in **4,178 counseling sessions** with our expert clinicians. **Eleven families** received Targeted Case Management — personalized connections to essential resources for children facing behavioral health challenges, intellectual disabilities, or complex medical needs.

Your generosity helps sustain Family Counseling Center, providing the staff with the space and tools needed to deliver consistent, high-quality care that helps families strengthen mental well-being and build resilience.

Within a short period of time in her therapy, we noticed positive changes in how our daughter approached situations, her self-talk, and emotional intelligence. This support has been one of the best things we could have done for our daughter.

JOURNEY PROGRAM

You Gave Parents a Strong Start

Thanks to your support, **33 young parents** in their teens and early 20s gained the guidance, tools, and skills they need to thrive academically, financially, and emotionally, while their **24 children** received childcare and essential supplies like diapers and wipes.

Through Journey Program, **nine couples** (18 individuals) also chose to co-parent in 2025. These young moms and dads learned how to work together to raise their children.

Last year, we also developed tools to track Journey parents' educational and career goals. These tools are now being implemented in 2026 to help each parent chart their own path to lasting success.

When I was pregnant with my first child, I was 19. I went into parenting without a lot of confidence. I wish all women got to have the support that Journey Program provides like my daughter does.

FAMILY ADOPTION PROGRAM

You Helped Families Feel Prepared

In 2025, the Family Adoption Program helped connect children with safe, stable homes while preparing families for the lifelong responsibility of welcoming a child. Through education, guidance, and ongoing support, we help build healthy, lasting families where children can thrive.

Last year, **seven children** were supported as they moved toward permanent homes with loving families. Our team walked alongside them through key milestones and transitions — from being matched with a family, to moving into their new home, and ongoing support afterward.

We also responded to **109 inquiries** from individuals and families exploring adoption, hosted **18 free information sessions**, and provided **25 in-depth consultations**. These conversations help families understand the emotional, practical, and legal aspects of adoption so they can make informed decisions and be fully prepared for the adoption process and welcoming a child.

Your generosity makes this foundational work possible. Your support funds ongoing post-adoption support and the early education that prepares families to take the first steps toward adoption, helping ensure children enter homes ready to provide the stability, care, and lifelong support they deserve.

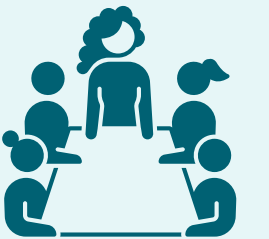

Augusta Elks Club contributed \$250 in support of our mission to build and strengthen families across Maine.

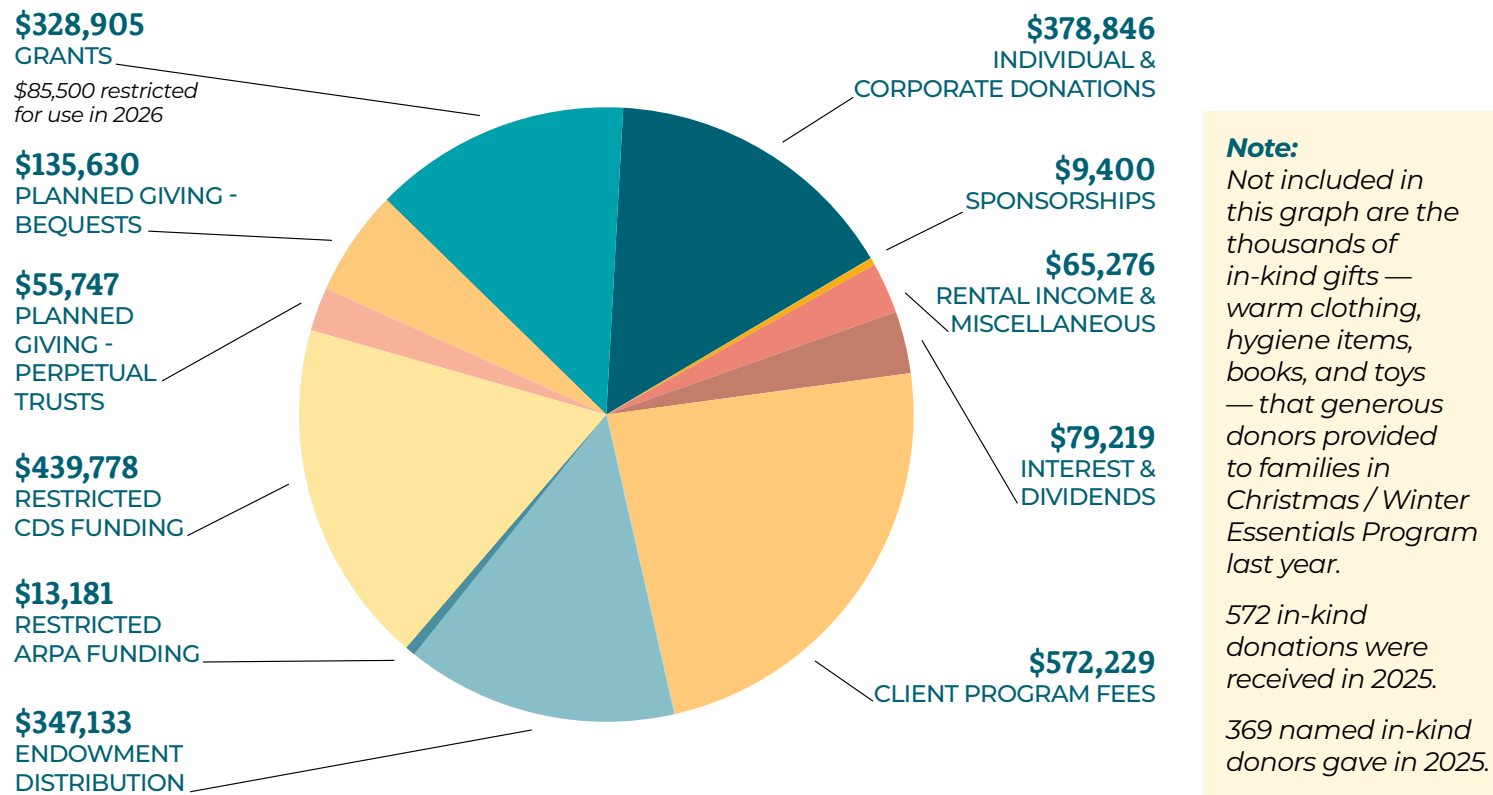
